Dear Chair Krueger and Ranking Member O'Mara:

The Primary Care Collaborative (PCC) supports the passage of <u>S6534B</u> to establish a primary care reform commission in New York. PCC is a nonprofit, nonpartisan multi-stakeholder coalition of 60+ organizational <u>Executive Members</u> ranging from clinicians and patient advocates to employer groups and health plans. PCC's members share a commitment to an equitable, high value health care system with primary care at its base: care that emphasizes comprehensiveness, longitudinal relationships, and "upstream" drivers for better patient experience and better health outcomes (See the <u>Shared Principles of Primary Care</u>).

In New York and across the United States, however, reality falls short of this vision. As Louise Cohen, Chief Executive Officer of the New York-based community investment organization, the Primary Care Development Corporation (a PCC Executive Member)recently observed, "primary care is the best way to deliver whole-person care in every life stage [...] yet we continue to undervalue and underfund it, and the effects are felt most acutely by marginalized communities."

As the front door of the health care system, primary care accounts for over <u>30 percent of all health care visits</u> while receiving only about 5 percent of health care expenditures overall. This low level of investment lags compared to other sectors of the health care system and other countries investment in primary care..² According to PCC's 2020 evidence report, in 2019 primary care spending across commercial payers nationwide was **only 4.7 percent** of total national commercial healthcare spending and falling since 2017. Additionally, **New York ranked 36 out of 50 states**, investing roughly 4.1 percent in primary care, well below the national average.³

The lack of investment in primary care is felt most strongly in communities facing health disparities (i.e., rural areas, communities of color, communities facing economic challenges). Strengthening primary care can play a key role in addressing these challenges. Findings from PCC's 2021 evidence report further suggest that communities with robust primary care, strong

public health infrastructure and social assets had fewer COVID-19 deaths compared to communities with weaker primary care, public health, and social assets.⁴

Increasing investment in primary care is one of the critical policy levers to ensure the health of all New York residents, especially those communities experiencing health disparities. If passed into law, New York bill S. 6534B would convene a collaborative of expert stakeholders to:

- Define primary care for the purposes of measuring spending
- Oversee the collection of spending data from all payers across New York State
- Publish a report on current primary care spending
- Provide recommendations to gradually increase the proportion of health care spending that goes to primary care across all payers in the state

The Primary Care Collaborative strongly urges you to pass this important legislation.
